#### CHANGE OF ADDRESS/RE-REGISTRATION/T,O (OF OTHER STATE VEHICLE) - INSTRUCTION

R.C. with relevant documents should be forwarded to RTO within 12 months from the date on which change of address is effected.

### Forms to be filled:

- 1. Form 33 HP continous (in duplicate is required)
- 2. Form 20 (chassis pencil print to be taken in the form.) H.P. continues in Duplicate is required.
- 3. Form 27 (court fee stamp for the value or Rs.6/- should be affixed in this form and if hypothecation continues this form should be given in duplicate)
- 4. HP continous No objection letter from financier is required to RTO chennai & also Form 33 & Form 20 Financier signature & Seal is required in duplicate.

## Other requirements:

- 1. Two xerox copies of PAN (Permanent Account Number) card or GIR no. of the Income Tax department. If the above is not available, Form 60 of I.T. Dept. has to be filled in duplicate.
- 2. Xerox copy of School / College certificate or Passport or Birth certificate as proof of age.
- 3. Xerox copy of Ration card, Electoral Roll Card, LIC policy, Passport, Pay slip issued by Central or State Government or local body as proof of address.\*
  - \* In case of Non Availability of any of these, Affidavit issued by Magistrate may be accepted.
- 4. Current valid Insurance certificate with the address in which vehicle has to be re-registered.
- 5. Self addressed envelope to ORA & self with postal stamp for the value of Rs. 76/-
- 6. Current valid Pollution certificate.
- 7. NOC of the original Registering Authority. (Form 28) " 2 Copies"
- 8. Passport size photograph 4 nos.
- 9. A declaration in Rs. 20/- stamp paper duly attested by Notary Public with photograph. (Format enclosed)
- 10. Entry Tax clearance certificate in Tamilnadu or Original Entry Tax challan ( if the vehicle has been originally registered and brought to the state within 18 months from the Date of Registration. )
- 11. Authorisation letter for AASI, to collect the documents from the RTO office ( court fee stamp for the value of Rs. 6/- to be affixed)
- 12. Police Clearance Certificate from 'Assistant Commissioner of Police, Crime Record Bureau, Egmore, Chennai- 600 008.'
